UQ COLLEGE

UQC Limited was formed in 2010 and is a wholly owned subsidiary company and Registered Training Organisation (RTO) for the University of Queensland (UQ). The purpose of UQC is to provide domestic students from low socioeconomic status (SES) backgrounds with access to further and higher education through the delivery of pathway programs. UQC delivers the Tertiary Preparation Program (TPP), a domestic Foundation pathway and several Vocational Education and Training (VET) courses including: 10238NAT Graduate Certificate in Positive Behaviour Support (Grad Cert PBS); 10239NAT Graduate Diploma in Positive Behaviour Support (Grad Dip PBS); 10765NAT Certificate in Adult Tertiary Preparation (Cert ATP) and 10246NAT Certificate IV in University Preparation (Cert UP).

UQC is currently working with the University to prepare for the introduction of a new UQ Foundation Program for both domestic and international students, for delivery commencing in January 2022.

DUTY STATEMENT

Primary Purpose of Position

The appointee will be responsible for the delivery and development of high-quality Foundation and VET programs (face-to-face and online) for both domestic and international students on a pathway to The University of Queensland. In conjunction with other academic managers, this position will oversee the supervision of all Foundation and VET teaching staff. This position is also responsible for ensuring that UQ College (UQC) meets all required regulatory and compliance obligations related to Foundation and VET and programs.

Duties

Duties and responsibilities include, but are not limited to:

- Lead and manage the planning, development and delivery of Foundation and VET courses and programs at UQC to ensure the most efficient and effective use of the physical resources and teaching staff, in accordance with specific internal Key Performance Indicators (KPIs)
- Provide advice and guidance with regard to contemporary best practice in quality assurance, innovative curriculum development, design and delivery, for all Foundation and VET programs
- Lead and manage academic Managers, Coordinators and teaching staff, including recruitment and selection, induction and professional development, performance management, teaching schedules, provision of support and advice

- Provide specific support and advice for Foundation and VET Teachers, and the Senior Leadership Team (SMT) as required
- Manage all Foundation and VET teacher leave requirements, relief teaching and teaching workspace allocation
- Oversee and manage non-teaching tasks such as curriculum development and projects (including online courses) for Foundation and VET programs
- Develop and maintain policies and procedures relevant for the effective and efficient delivery of Foundation and VET teaching and learning, in conjunction with other Seniors Managers
- Coordinate and manage documentation and processes required to meet regulatory requirements and compliance for TEQSA, ASQA, CRICOS and NEAS, in conjunction other Senior Managers
- Oversee student orientation, entrance testing, academic assessment and the academic and welfare counselling of students, in conjunction with the Senior Managers
- Liaise with UQ Faculties/Schools/Divisions program planning, development and delivery and provide accurate and timely analytics and metric regarding student success, progression and retention
- Participate in and represent UQC at local, national and international seminars, workshops and conferences
- Teach to a minimum of 0.2 FTE over the calendar year
- Maintain teaching credentials and expertise through classroom teaching and attendance at appropriate professional development events
- Undertake specific duties as directed by the Chief Executive Officer (CEO).

- A team player with excellent interpersonal and communication skills, and demonstrated ability to work collaboratively and flexibly with all colleagues across UQC and the University
- Proven ability to remain calm under pressure, to manage time effectively and to find quick and appropriate solutions to problems and challenges in a complex work environment.
