NEAS Australia ("NEAS", "we", "our", "us") reserves the right to update these Terms and Conditions at any time. Any changes will apply to future registrations and will not affect registrations already completed.

NEAS may, where reasonably necessary, restrict participation in the NEAS Conference and associated events and activities.

EVENT REGISTRATION

For questions regarding registration, please contact the NEAS Team at neas@neas.org.au. All fees, inclusions, and registration offerings are subject to change prior to purchase.

REGISTRATION, SUBSTITUTIONS AND CHANGES

Conference passes may be transferred to another person. Requests must:

- be made in writing via email to neas@neas.org.au, and
- be received no later than 11:59pm AEST, seven (7) days before the conference begins.

Transfers are granted at NEAS' discretion.

Pass sharing is not permitted without prior written approval from NEAS. Unauthorised pass sharing may result in cancellation of the registration without refund.

Lost or misplaced passes may be replaced at NEAS' discretion, and replacement fees may apply.

CANCELLATIONS AND REFUNDS

A registration fee is required to attend the conference.

1. Voluntary cancellations

Requests for voluntary cancellation must be submitted in writing to neas@neas.org.au no later than 30 days before the conference.

- Approved cancellations will incur a \$150 administration fee.
- Requests received after this deadline cannot be accepted and will not be eligible for a refund.

Refund requests will be assessed within 10 working days, and outcomes will be provided in writing. Approved refunds will be processed within 28 days.

3. Non-attendance

Registrants who do not attend the event and have not cancelled according to this policy will not be eligible for a refund.

REGISTRATION PACKAGES AND PAYMENTS

All prices are quoted in Australian Dollars (AUD) and include GST.

Payment is required at time of registration via credit card or invoice.

Registrants travelling from outside Australia are responsible for ensuring their visa is obtained in time. Visa delays do not entitle the registrant to a refund.

NEAS is not responsible for any costs related to travel, accommodation, or third-party bookings. Cancellation fees imposed by airlines, hotels, or travel providers are the responsibility of the registrant.

Currency exchange variations between payment and refund dates (if applicable) are beyond NEAS' control and may affect refund amounts.

NEAS may disclose your information to third-party service providers engaged to assist with event operations (e.g., registration services, venue systems). These providers are required to protect your information.

With your consent, NEAS may also share your information with event sponsors for marketing or networking purposes. You may withdraw consent at any time.

Any information you provide directly to sponsors or exhibitors is your responsibility. NEAS is not responsible for how sponsors or exhibitors handle personal information provided to them by attendees.
